Feel jolted by the combination of Actor's Equity Safety Protocols, municipality guidelines and now Biden COVID-19 mandates?

Yes? You are not alone!

Gearing up to take the stage with responsibility for cast, crew, and patrons will require medically skilled navigation and infection control expertise.

Here is what you need to know regarding vaccinations, testing, and science-based COVID-19 management to maintain a healthy workforce within a safe workplace.

COVID-19 VACCINES WORK

Contrary to **myths and conspiracy theories**, COVID-19 vaccines are safe and effective.

Studies conducted by the CDC (Centers for Disease Control), reveal vaccine-induced immunity has significantly reduced COVID-related hospitalization and severe symptom development. While new infectious disease strains, such as Delta, pose risk to vaccinated and unvaccinated individuals, should a vaccinated team member have breakthrough infection, symptoms are typically mild.

ACTOR'S EQUITY UNION'S VACCINE MANDATE

As announced in July 2021, the Broadway League and Actors' Equity (AEA), have adopted new safety protocols and vaccination mandates.

AEA Vaccine Mandates focus on four principles



Vaccinating cast and crew members against COVID-19



Weekly COVID-19 testing for fully vaccinated individuals



Physical distancing and masking for the unvaccinated and juveniles under age 12



COVID-19 testing for the unvaccinated twice a week



Such regulation provides autonomous flexibility for producers to accommodate those who are not vaccinated due to **disability** or **religious beliefs**.

The protocols are applicable to Broadway productions and countrywide sit-down shows on the League's production contract.

The Broadway League and AEA have established similar vaccination policy requirement for touring productions, focusing on:

- Vaccinating all touring members
- Masking for all non-performing cast, crew, and musicians
- Maintaining physical distancing
